Covid-19 **Pre-Event Guidance**



Checking for Covid-19 symptoms before the London Legal Walk.

Please DO NOT attend the event if any of the following applies to you before Monday 18 October:

- You have received a positive Covid-19 test result.
- You are experiencing any Covid-19 symptoms.
- You have experienced any Covid-19 symptoms within the 14 days leading up to the event.

Take a lateral flow test before the event:

• We highly recommend that every attendee of the London Legal Walk takes a Covid-19 lateral flow on the Sunday evening or Monday morning (within 24 hours) of your Legal Walk).

The main symptoms of Covid-19 include:

- A new, continous cough
- A high temperature
- A loss of taste and smell

- If you receive a positive result please do not attend.

Feeling Unwell?

- We would also advise that if you have any viral symptoms e.g. sore throat, temperature, cough, or runny nose that you should not take part on one of the official London Legal Walk routes on Monday 18 October.
- This applies even if your lateral flow test for Covid-19 has come back as a negative result.

The registration time has been extended this year to 2pm - 7pm. Only the team organiser needs to register at the desk.




We have added an additional 10km route, River Route East, to avoid large gatherings whilst teams take part.
