- Two 10km routes

Covid-19 Pre-Event Guidance



Checking for Covid-19 symptoms before the London Legal Walk.

Please DO NOT attend the event if any of the following applies to you before Tuesday 28 June

- You have received a positive Covid-19 test result.
- You are experiencing any Covid-19 symptoms.
- You have experienced any Covid-19 symptoms within the 14 days leading up to the event.

The main symptoms of Covid-19 include:

- A new, continuous cough
- A high temperature
- A loss of taste and smell
- Tired / aching body
- Shortness of breath
- A headache
- Sore throat

Take a lateral flow test before the event:

- We recommend that every attendee of the London Legal Walk takes a Covid-19 lateral flow on the Monday evening or Tuesday morning (within 24 hours of your Legal Walk).
- If you receive a positive result please do not attend.

Feeling Unwell?

- We would also advise that if you have any viral symptoms e.g. sore throat, temperature, cough, or runny nose that you should not take part on one of the official London Legal Walk routes on Tuesday 28 June
- This applies even if your lateral flow test for Covid-19 has come back as a negative result.

There are 2 available routes to avoid large gatherings whilst teams take part.




The Street Party on Carey Street will have a one-way system in place. Please adhere to this upon arrival.





Hand sanitiser will be provided at all key touch points, and face masks are encouraged in areas of crowding.



The selfie station returns this year (with plenty of sanitiser). Team photos are also available, though please be mindful of anyone continuing to socially distance.



Participants have the option to walk locally to their home instead of taking part in central London.
