### INTRODUCTION FROM THE CHAIR & CEO

2024 was a landmark year for the London Legal Support Trust (LLST). Across London and the South East need for free legal advice continued to rise. The housing crisis worsened, legal aid cuts persisted, and growing pressures on the immigration and asylum system left many without vital support.

In response, LLST delivered over £3.5 million in grants and partnership funding to frontline legal advice centres, helping to prevent homelessness, support survivors of abuse, secure welfare entitlements, and protect vulnerable people across our communities.

The London Legal Walk marked its 20th year by surpassing £1 million for the first time. This milestone was made possible by the dedication of thousands of walkers, firms, chambers, and supporters.

## Celebrating 20 Years of LLST







In 2024, we celebrated 20 years of the London Legal Support Trust. Since 2004, LLST has grown significantly from its humble beginnings. Over the years the Trust, has continually developed innovative ways to raise vital funds, share knowledge, and strengthen the advice sector, ensuring that access to justice is available for everyone, whenever and wherever it is needed.













## The Need for Free Legal Advice







The need for free legal advice in London and the South East reached unprecedented levels in 2024, driven by rising housing insecurity, ongoing public service costs, and worsening economic pressures.

#### **London Legal Walk**

London Legal Walk is the biggest fundraising event in the legal calendar, raising £1,042,610 in 2024. 18,000 legal professionals from over 1,100 teams participated in the 2024 London Legal Walk, representing every aspect of the legal profession, including judges, solicitors' firms and barristers' chambers, in-house lawyers, Law Centres, law schools, independent advice agencies and Citizens Advice.

LLST's flagship event, the London Legal Walk, has been held annually since 2005. Over the last two decades, the Walk has grown from just 330 walkers in 2005 to over 16,000 in recent years, raising over £11.5 million to support access to justice. The Walk brings together thousands of participants from across the legal sector to take on a 10km Walk through central London. Starting and ending with a street party behind the Royal Courts of Justice.

#### Champions of Justice

In 2024, we organised a series of recruitment events for our Champions for Justice initiative, successfully securing new Champions across all levels of support. Our thanks go to. Freshfields and Hogan Lovells for hosting our engagement dinners.

Champions commit to monthly donations, to support the work of the advice centres in a regular and predictable way to ensure we can plan for the grants we give. Firms often give a donation as part of their support through hosting a Champions' dinner. Champions for Justice come from across the legal sector, including law firms, chambers and supplier companies and their funds support the sustainability of the free legal advice agencies.

#### **Corporate Partnerships**

One important way in which law firms and others support LLST is through in-kind donations, and they really are invaluable.

#### Projects and Partnerships Driving Impact



#### **Advice Workforce Development Fund (AWDF)**

AWDF was created as a Propel-funded programme following the 2020 "Addressing Skills Gap research", which called for funders and advice organisations to work together to tackle sector-wide workforce challenges. Through cross-sector collaboration, AWDF aims to build a sustainable, effective, and diverse advice workforce that serves Londoners at the point of need.

Now in its second year, AWDF has provided funding for eight projects which aim to make the sector more inclusive, accessible, and sustainable. Through this:

- 386 participants across London have benefited.
- 12 apprentice/trainee solicitors with Legal Advice Centre (University House), many of whom would not have had the opportunity to train due to systemic barriers, have taken part alongside 238 people (including staff and volunteers from local community organisations) trained on critical areas of social welfare law
- At the Disability Law Service, **2 trainee solicitors and 1 advice worker** within a community partner, all of whom were disabled people, provided social welfare legal advice that **benefited 631 individuals.**

#### Jamal's Journey from Care Coordinator to Aspiring Advisor




With support from Propel funding, Jamal was able to take an important step forward in his career, moving beyond his role as a care coordinator at Mushkil Asaan into training with Citizens Advice Wandsworth. Until this opportunity, advisory work had felt out of reach, as his organisation didn't provide structured training in this area. At first, the experience was overwhelming, but Jamal soon grew in confidence, developing his communication skills, learning how to navigate complex cases, and gaining valuable insight from colleagues and workshops. He particularly valued the chance to engage directly with clients and sees how these skills can transform the support people receive.

Inspired by what he has achieved, Jamal now hopes to qualify as an immigration advisor, a role he believes is critically needed in his community. He is determined to continue his journey in the advice sector.

#### Billing Coordinator Project with the Legal Education Foundation



The fourth Billing Coordinator Project, part funded by the Legal Education Foundation, launched in mid-2024. This cohort involves three London-based advice agencies. Two of the agencies have some national reach, and together they cover a wide range of social welfare law areas.

This cohort builds on the success of previous phases. The project is designed to strengthen the capacity of legal advice agencies by improving legal aid billing efficiency and clear backlogs in casework.

#### **Advising Londoners Partnership (Cost of Living Advice Project)**

The Advising Londoners Partnership (ALP) together Greater brings the London Authority (GLA), London Legal Support Trust (LLST), and the London Citizens Advice network to tackle the ongoing cost of living crisis and support Londoners mounting financial pressures. We do this by providing funding for advice through our delivery partners, which include law centres and other advice agencies across London.





In 2024, the project funded 21 delivery partners who provided vital advice and guidance to over 12,500 Londoners, helping them navigate complex financial and social challenges. Through this work, our partners secured over £6.5 million in income improvements, directly easing financial stress and making a real difference in people's lives across the capital.

#### How our work is having an impact?



At 67, \*Robert was already navigating the daily challenges of life with disabilities when the rising cost of living turned his financial struggles into a crisis. Living on limited resources, he desperately needed support to access benefits that could provide a lifeline.

An unfair parking ticket, despite his blue badge, added to the strain, leaving him panicked, hopeless, and fearing bailiffs might even take his wheelchair.

When Robert was referred to a Law Centre, everything began to change. Ash, an experienced Money Advice caseworker, took the time to listen, explain his options clearly, and build a plan to sustain his situation. For the first time in months, Robert felt understood and reassured.

My first conversation with Ash significantly eased my anxiety. He was incredibly knowledgeable, and it was obvious that he knew what he was doing. Each question I asked had a clear, immediate answer.

With Ash's support, Robert successfully applied for benefits he hadn't realised he was entitled to, increasing his annual income by £16,000.

Robert continues rebuilding his sense of security and looking forward with renewed hope. His story shows the vital difference timely expert advice makes.

I felt more at ease and confident about my situation. Your support really took a load off my mind. I still have ongoing issues, but taking care of this one helped me to focus on the rest.

### Sector Development and Collaboration



The London Specialist Advice Forum was created in 2020 in response to the sector's need for a space to share ideas, discuss issues, and offer peer support. LLST coordinates the Forum, and together with the Steering Group, identifies relevant topics and invites speakers, ensuring the Forum remains reflective of, and responsive to, the needs and priorities of the sector.

In 2024, approximately 180 people took part in the Forum's activities, including quarterly meetings, in-person sector socials and networking sessions, and smaller subgroup meetings. These subgroups bring together practitioners to focus on specific areas such as community care, SQE Apprentice peer support, and legal aid billing.

Speakers and attendees represented a diverse range of organisations, including independent advice agencies, Law Centres, Citizens Advice, Toynbee Hall, Access Social Care, Child Poverty Action Group, Public Interest Law Centre, the Law Centres Network, as well as funders such as Trust for London and the National Lottery Community Fund.

Thank you so much for your ongoing financial support and for all that you do to support our organisation and the advice sector more widely. I very much enjoyed listening to your presentation about the LLST's work at November's Specialist Advice Forum and was hugely impressed by the range of initiatives that you are leading, particularly around addressing the sector's future workforce. It is wonderful to hear about such positive work in what has been a politically very grim year!

#### **Centres of Excellence (CoEx)**

The Centres of Excellence (CoEx) programme, supported by City Bridge Foundation and National Lottery Community Fund, strengthens the free legal advice sector through unrestricted grants, consultancy, and training.

In 2024, the programme celebrated its 10th anniversary. Over the last decade, it has supported 43 organisations, many for over 7 years, distributing more than £3.6 million in grants. The programme has provided hundreds of hours of consultancy and trained staff in areas including resilience, GDPR, risk management, and equality and diversity.

In response to evolving sector needs, a comprehensive programme review was conducted last year, gathering feedback from delivery partners, funders, and stakeholders. Recommendations were shared in summer 2024, and work is now underway to redesign the programme. The refresh aims to better address current sector challenges while maintaining long-term support for existing partners and creating opportunities to welcome new organisations.

This evolution aims to ensure the programme remains responsive and effective in building capacity and sustainability across the free legal advice sector, helping us all meet the challenges that lie ahead, together.

#### **Money Saving Project and Training Initiatives**

We continued to support the free legal advice organisations through providing money savings groups, information about discounts or exemptions available to charities, and managing in kind donations from law firms or chambers.

Specific arrangements with suppliers sourced from sector recommendations help to save money for charities in a variety of areas including stationery, photocopiers and printers, second hand legal texts, storage solutions, telephony and more.


